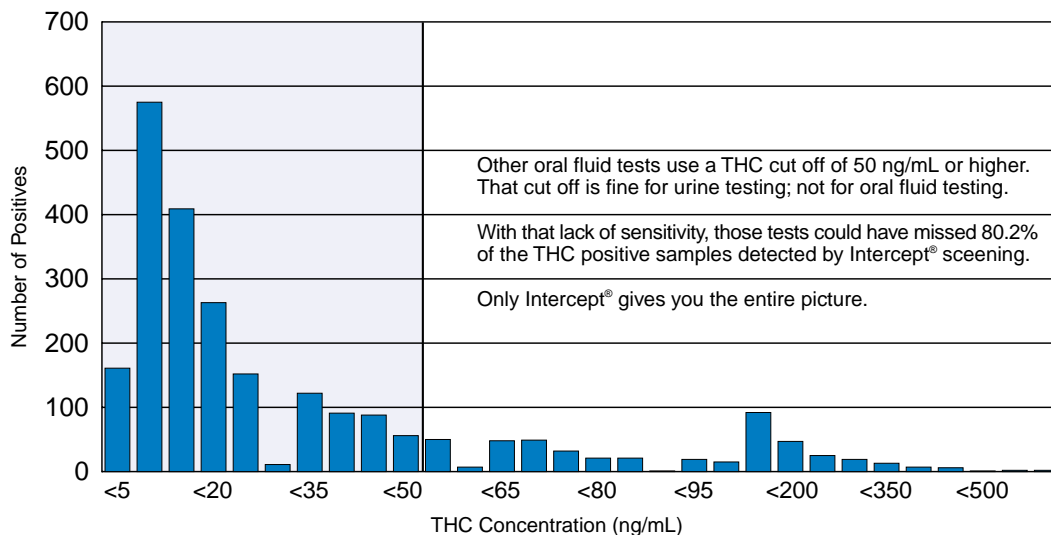

Simple Collection Procedure ... Swab, Snap, Seal

Donor's mouth must be clear for 10 minutes prior to providing sample.

Place collection pad between lower cheek and gums and gently rub back and forth until the pad is moist.
Once moist, leave collection pad between cheek and gums for three (3) minutes.

After three minutes, open specimen vial in an upright position by gently rocking the cap back and forth

Push collection pad into specimen vial as far as it will go.

Snap collection wand at scored line against side of vial. Place cap onto vial until it snaps.
Do not tilt vial or spill fluid inside.

Place tamper evident seal across top of specimen vial if required.

Seal Intercept® specimen vial(s) and chain of custody form into a specimen bag for shipment to laboratory.
